Biden traveled in an 85-car long motorcade to preach climate change-Right Wing Insider excerpts

The world leaders are gathering in Glasgow for the United Nation's COP 26 summit that's considered the largest climate meeting since 2015. All of these leaders are seeing the solutions for the survival of the world by finding ways to curb carbon emissions.

Just before the summit that would be attended by almost 200 countries, Biden's long motorcade made enough carbon emissions to easily expose his hypocrisy regarding climate change.

WALMART Teaches Critical Race Theory

Walmart Inc. has launched a critical race theory training program that denounces the United States as a "white supremacy system" and teaches white, hourly wage employees that they are guilty of "white supremacy thinking" and "internalized racial superiority."

According to a cache of internal documents, Walmart launched the program in 2018 in partnership with the Racial Equity Institute, a Greensboro, North Carolina, consulting firm that has worked extensively with universities, government agencies, and private corporations. The program is based on the core principles of critical race theory, including "intersectionality," "internalized racial oppression," "internalized racial inferiority," and "white anti-racist development." Since the program's launch, Walmart has trained more than 1,000 employees and made the program mandatory for executives and recommended for hourly wage workers in Walmart stores. When reached for comment, Walmart confirmed that the company has "engaged REI for a number of training sessions since 2018" and has "found these sessions to be thought provoking and constructive."

The program begins with the claim that the United States is a "white supremacy system," designed by white Europeans "for the purpose of assigning and maintaining white skin access to power and privilege." American history is presented as a long sequence of oppressions, from the "construction of a 'white race'" by colonists in 1680 to President Obama's stimulus legislation in 2009, "another race neutral act that has disproportionately benefited white people." Consequently, the Walmart program argues, white Americans have been subjected to "racist conditioning" that indoctrinates them into "white supremacy," or the view "that white people and the ideas, thoughts, beliefs, and actions of white people are superior to People of Color and their ideas, thoughts, beliefs, and actions."

Will Nancy bring this to the floor, probably not.

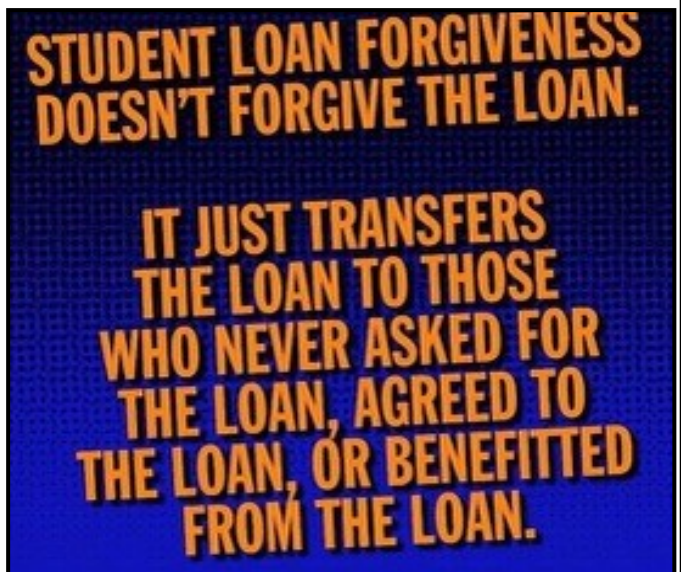
34% of White Students Lied About Their Race to Improve Admissions Chances at Colleges

According to a survey carried out by [Intelligent.com](#), 34% of college students surveyed said they had previously lied about their race on applications:

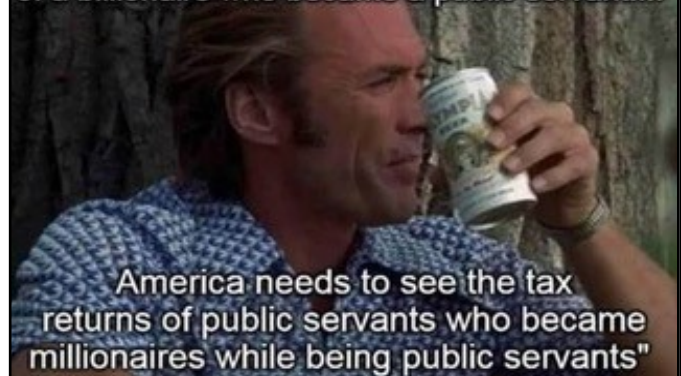
Seventy-seven percent of people who claimed to be a racial minority on their applications were accepted by the colleges to which they lied.

Mutiny, A Dem Coup, and TREASON

The world was rocked on September 14th as news broke of a new book, aptly named "Peril" being released by Bob Woodward and Robert Costa which details nothing short of a mutiny, a Democrat-led Coup, and an act of treason against the American people. 18 U.S.C. §2381. Treason

Whoever, owing allegiance to the United States, levies war against them or adheres to their enemies, giving them aid and comfort within the United States or elsewhere, is guilty of treason and shall suffer death, or shall be imprisoned not less than five years and fined under this title but not less than \$10,000; and shall be incapable of holding any office under the United States.

According to [The Washington Post](#), the first call of two between General Milley and Chinese General Li Zuocheng of the Peoples Liberation Army took place October 30th, before the November 2020 election. In the book it is alleged that this call occurred after "Milley's review of intelligence suggesting the Chinese believed the United States was preparing to attack. That belief, the authors write, was based on tensions over [military exercises in the South China Sea](#), and deepened by Trump's [belligerent rhetoric](#) toward China."

"General Li, I want to assure you that the American

government is stable and everything is going to be okay," Milley told him. "We are not going to attack or conduct any kinetic operations against you."

Milley not only subverted any possible use of force, weakening and even negating our country's bargaining positions with China and completely negating our doctrine of deterrence in the Taiwan Strait and the South China Sea but Milley even went on to promise that in the event of military action being ordered, he would call the Chinese and **WARN THEM**. Placing the lives of American service members assigned to conduct such military actions in mortal danger.

"General Li, you and I have known each other for now five years. If we're going to attack, I'm going to call you ahead of time. It's not going to be a surprise."

BUSTED! Days Before The Election Fulton County Bought 1 Million Absentee Ballots, But NO ENVELOPES

Fulton County, Georgia received more than one million blank absentee ballots just ten days before the election. That would not give them enough time to fold, place into envelopes, and mail in time for the election. But, then that was possibly not the reason that they bought them, because if it was, they would have also bought envelopes to mail them with, but they didn't. Even the dead voters who went with Biden must find this strange.

The company that supplied the ballots to Georgia, Runbeck, also supplied ballots to Arizona, including Maricopa County.

This would certainly explain why election workers saw pristine ballots being run through the tabulators. Do not expect Brad Raffensperger to investigate this as it is possible that he already knew it.

We know that Runbeck shipped thousands of ballots to the same guy in Georgia. This is the same man who came up with the fake water leak story. Was he buying time in order to add enough ballots to eke out a Biden win?

President Trump held a large lead on election night in all of the swing states, and in all of those states, there were late-night ballot drops which would be at a time when they knew how many votes they needed to take the lead.

We also know Brian Runbeck works for the company with his name. Although not listed as a member of the Executive Team, Brian Runbeck, identifies himself as the Client Services Manager/Project Manager and Production Coordinator at Runbeck Election Services. He [manages the production of election ballots](#) and related official election material. He claims he handles high pressure deadlines and high volume production.

Mr. Runbeck also made **50 separate donations** to Act Blue, Biden for President and the Democratic Senatorial Campaign Committee between August 15 and October 30, 2020.

NOTE that the BAR CODE is missing from these ballots. This is important because as IT specialist Javon Pulitzer noted in testimony earlier this week, the Fulton County ballots in the general election for GOP pre-cincts included a barcode while the ballots in Democrat districts did not include the barcode.

Did Mark Zuckerberg Buy The Oval Office For Joe Biden?

Election integrity is on everyone's mind, and they all have their reasons for having concerns. The newest revelation is that Mark Zuckerberg may have interfered with the 2020 election by running non-profits that favored President Joe Biden. The unprecedented move may have caused more concern for voters who already had issues handling the 2020 election.

Zuckerberg poured \$419.5 million into The Center for Technology and Civic Life (CTCL) and The Center for Election Innovation and Research (CEIR) to invest in local government elections offices. According to [The Federalist](#), the money came with strings attached.

According to the Federalist, the grants went to things such as "vote navigators" who "assisted voters, potentially at their front doors, to answer questions, assist in ballot curing and to witness absentee ballot signatures."

[RealClear Investigations](#) also designed absentee ballot forms and instructions, helped with voter registration letters for felons who weren't allowed to vote, and tested automatic voter registration systems across the country. It's also claimed that Zuckerberg's grants helped work directly with election offices in Georgia and Utah, but that's not all.

Everyone remembers the censorship of conservative views on Facebook. That's not new, but it hits home with the latest information coming out and how far big tech companies are willing to go to ensure their chosen candidate wins. It's disturbing also to realize that the White House announced earlier in 2021 that it was working for Facebook directly to flag "misinformation."

We hear about dark money and businesses buying advertising. Still, we've never seen hundreds of millions of private cash go into an election, according to Hayden Dublois, a researcher with the Foundation for Government Accountability. And there were no laws in place to stop it in the states."

US Announces Support for Taiwan to Join the U.N.

The United States backed Taiwan's inclusion in the United Nations system, a move that is likely to rankle China, which considers the island under the authority of Beijing.

Secretary of State Antony Blinken called "Taiwan's meaningful participation in the UN system" a "pragmatic" issue and not a political one.

"The fact that Taiwan participated robustly in certain UN specialized agencies for the vast majority of the past 50 years is evidence of the value the international community places in Taiwan's contributions," Blinken said in a statement.

The secretary praised the island as a democratic success story and representing values that "align" with the U.N. He added that Taiwan's exclusion from the World Health Assembly robs the global community of its "world-class" response to the COVID-19 pandemic and raised the issue that Taiwan's scientists, technical experts, business persons, artists, educators, students and human rights advocates are blocked from participating as members of civil society.



Supreme Court Divided': Biden Commission Gives Surprising News On-Court Expansion

Biden wants to add in extreme liberal justices that would sway the judicial process in the Democrat's direction.

Gun laws, mandates, lockdowns, and other leftist

measures have been thrown into local federal courts, but so far, the Supreme Court hasn't gotten a chance to rule on many of the issues lately.

Biden's commission comprises law professors, constitutional scholars, and former judges who have been considering the options of adding more justices.

The commission is divided. They made an argument for court-packing and against it and suggested term limits along with their determination.

The report said, "The risks of court expansion are considerable, including that it could undermine the very goal of some of its proponents of restoring the court's legitimacy." Not many people will genuinely respect the findings of the Supreme Court if it's done in political malice.

The report also said, "If the country and the political system were to be embroiled in repeated fights over court expansion, that alone could harm the Supreme Court's public reputation."

The commission suggested an 18-year term limit that would regulate when justices would be circulated, which seems reasonable, but maybe too long. The First Thanksgiving What? December 18th, 1777?? By Betts Rivét, Americanism

Many myths surround the first Thanksgiving. Very little is actually known about the event because only two firsthand accounts of the feast were ever written.

One is that on December 18th, 1777 the United States Continental Congress declared the first national Thanksgiving to be December 18, 1777, a reaction of the recent victory at the Battle of Saratoga, **but** in 1789, George Washington declared that the National Thanksgiving to be the last Thursday in November.

The second account is the pilgrims who came over from England to settle in a new country. There were only 53 pilgrims at the second 'first' Thanksgiving celebrating the successful fall harvest in their small colony at Plymouth Rock in the 17th century. Disease and starvation struck down half the original 102 colonists during the long journey on The Mayflower and the first winter in the New World, leaving only 53 people, mostly men.

With the help of the local Wampanoag tribe, the 53 pilgrims made it through the first winter. The Indian's leader, Massasoit, taught the pilgrims how to forage for food, how to cook animals, and how to make animal skins into blankets.

Although the modern day Thanksgiving feast takes place on the fourth Thursday of November, the feast most likely happened sometime between September and November of 1621.

Thanksgiving is not a reaction to a recent victory or even a celebration of a fall harvest. Our modern Thanksgivings are feasts with family and friends. It is a day that we all give thanks for family, personal victories and good fortunes.
