A Message from Our President Deborah Pauly, J.D.



Preparing for the Harvest: CPOC's Interactive Workshop yields fruit

e're coming off a very successful September meeting after a two-month summer hiatus. The Interactive Workshop lived up to the hype and then some. Instead of the top-down directive, one-way street communication approach we've become accustomed to experiencing in most political organizations, we wanted to hear from our members. We wanted a bottom-up approach.

We took a risk by doing something so different and it paid dividends.

This classic brainstorming session was designed to provide focus and direction for CPOC during the coming year. We nurtured a judgment-free zone, where ideas flowed, creative solutions were developed and "out-of-the box" thinking was encouraged. Open conversation and the admonishment to listen, listen, listen and allow only one conversation at a time, also lead to better relationships being formed during the facilitator-lead discussions.

Input will be used to develop our plan for 2023 with a focus on being prepared for heavy lifting in 2024. **This is all about 2024!** There were many great ideas that emerged and many will be pursued. We also were able to identify leaders that naturally surfaced during our time together. At the conclusion of the working dinner, each table sent a representative to present a Recap Out Brief of ideas, goals and potential projects.

I'd like to thank Susan Stivers and Cheryl Frink for bringing this idea to our board late last Spring. A special thanks to Lisa Franks and Stephanie Townsend for their work on the committee. Turn to page 5 for coverage.

If you've been to a CPOC meeting, you've heard me say "Stay and Play in Your Own Back Yard" many times. It's easy to have our attentions and energies diverted, but we can have greater influence closer to home. Our local elected officials are suppose to be accessible to us and the first line of defense against an over-reaching state or federal government. If our elected officials are ceding authority to those up the food chain, what is the point? We have communism by default if power is concentrated and wielded from on high. We need to get rid of those who don't take that charge to heart.

There have been a few changes in CPOC leadership this month. It has been suggested that James Peters should pursue regional election integrity projects with those from other counties, which is where his passions reside. He may bring back ideas to us when it is appropriate to collaborate. I have asked Susan and Cheryl to lead up our EIC team efforts on an interim basis. They are forming a more Orange County-focused committee. So far, they have started a sustained schedule of speaking at the OC Board of Supervisors as CPOC presents our concerns. There are always slots available on the schedule and they help with talking points for those members who are not as comfortable in the public speaking arena. They are meeting with the ROV's operations director early this month. They have submitted short and long-term goals for the board's consideration...so, standby.



Speaking of new leadership, it is time for CPOC to hold elections for the offices of President, Vice President for Ways and Means, Treasurer and Recording Secretary. If anyone is interested in those offices, please contact any member of the CPOC board with your interest. We particularly need a Treasurer going forward in in 2023. Nancy Tucker was very gracious to stay on an additional year through 2022 to assist us during a complicated transition period. She, along with our Finance Director Carol Bowen, will be available to train and counsel the incoming treasurer. You won't have to fly solo until you feel ready. We need nominations by October 20, so that we can provide notice to the members. Voting will take place at the November meeting.

In October, we are reprising the Parade At The Podium, which was such a hit leading into the June Primary. We are focusing on local candidates for school boards, city councils and water districts. We are also happy to welcome any county or state-level candidates who want to secure CPOC's support. If you know a worthy candidate in your area, invite them to present themselves October 20. One CPOC member invited and even paid for the entry fee for her favorite candidate. I thought that was

a very nice idea.

Registration is open for the Fantasy of Trees on December 3. This is our only fundraiser and keeps us going for the year. Plus, it is just loads of fun - part politics and part traditional kick-off to the Christmas and Hanukkah season with a few surprises thrown in. You and your guests will have a blast! (1) **RULE OF 10**

Each member identifies their "targets" who they would contact with news about Orange County and assist with spreading news and taking action if needed. (target is the members creating a distribution of 10 friends/family/co workers they email/call/text with details about any "calls to action")

Each of these 10 members will ask their targets to find 10 "targets" of their own to keep the communication simple. And so on....

(2) INFORMATION/MESSAGING

Committee Chair requests other teams (from CPOC workshop: Legal, Legislation, Health, Education, Election Integrity, Health) to email her with current news and actions to be taken in Orange County

CPOC ask all members to share ideas with Shelley about what news they feel CPOC should focus.

Members can contact Shelley directly with suggestions.

Shelley presents these ideas to the COMMUNICATIONS COM-MITEE (CC) and the team decides to move forward then creates the message:

- * message
- * who to contact
- * share with targets
- * tips

COMMUNICATION

Shelley sends message to Deborah for edits and final approval

Deborah and sends to Mary

Mary sends an email blast to all members and adds into the CPOC newsletter

Shelley shares on Social Media and with James Wallace

CCT shares with local newspapers (CCT team to compile a list of local newspapers in OC to contact)

FUNCTIONAL: Legislation

Committee Chair: Betty Robinson



The team believes that the first step is to create a group of volunteers that will determine, with input from the CPOC membership, which matters to focus on.

The team would look to focus on related bills to be researched/ monitored from various sources: the media, website of elected officials, especially those who author bills not compatible with conservative values, various ca.gov sites, suggestions from CPOC members and others.

When needed, the team would compose detailed Action Alerts, to be posted in the CPOC website. Some mechanism of feedback from members would be helpful.

Ways to support or oppose bills:

- Participate/monitor state Senate and Assembly committee hearings (now held remotely). Send emails to the committee, which then become part of the record. Register for emailed bill updates on ca.gov.
- Make phone calls or send emails to elected officials, including the governor.
- Schedule visits to elected officials' offices, also cultivate relationships while there.
- Write letters to the editor to local newspapers; cultivate relationships with their reporters.
- Post on social media sites.

ISSUE: Education

Committee Chair: Robert Walton





Our committee met and identified the goals they think we should pursue if we are to save our kids from the leftist hold on our education curriculum. These goals include:

- Stop gender confusion
- Stop the push for transgenderism
- Stop CRT and stop the false history of the 1619 outline.

As the same time education needs to restore:

- Shop classes
- ROTC on campus
- Discipline on campus
- Return to phonics when teaching English


September 2022. Why are these elected officials clinging to lockdown "plandemic" mentality?

FANTASY OF TREES A Time for Angels



Conflict of Interest at OC Registrar of Voters



Neal Kelley's Consulting Contract Should be Rescinded

Some of the shenanigans that takes place in Orange County government is truly astounding. You will rarely learn about it in the local (often left leaning) media. However, with the growing influence of Conservative Patriots of Orange County, the organization will regularly alert its members so we can voice and protest our disapproval at decisions that seem to go against the community's best interests.

A shocking example of elitist Orange County government mentality is the Orange County Board of Supervisors awarding a Registrar of Voters consulting contract to Neal Kelley shortly after Kelley RETIRED as the county's registrar.

Kelley retired in March 2022 after serving as registrar since 2005. Bob Page was named the



new registrar. Usually when you hire someone the assumption is they have the skill set to perform the duties of the job. Obviously, that doesn't appear to be the case with Page since almost immediately after taking over the Registrar of Voters, the Board of Supervisors awarded Kelley with a TWO-YEAR

consulting contract to do exactly what Page was hired to do.

You simply cannot make up this story about how these groupies take care of one another to the questionable detriment of the public. (We admit this sounds like a *Babylon Bee* article.)

Orange County, California is the fifth largest voting jurisdiction in the United States, serving nearly 2 million registered voters. (And who knows how many fraudulent voters?) As registrar, Kelley's official role as the County's chief election official included responsibility for conducting elections, verifying petitions, and maintaining voter records. Whether the Orange County Registrar of Voters performed those duties in a manner that would make all voters proud is up for debate.

But now there is an obvious conflict of interest between Neal Kelley's Orange County Registrar of Voters consulting gig and his new job as chairman for the just formed national "The Committee for Safe and Secure Elections." And what is the goal of this committee? Its mission statement reads:

"To protect election workers and voters against violence, threats and intimidation."

Yet, their own website admits that this so-called protection is not needed. Its website reads:

"We are unaware of physical violence against any official for their role in an election in the United States, though the risk may be growing."

Basically, Neal Kelley leads an organization that wants to protect election workers from a situation that the organization admits does NOT exist.

If that wasn't disturbing enough to warrant the Board of Supervisors to rescind Kelley's consulting contract, consider who is supporting the misleading named "Committee for Safe and Secure Elections." Their leadership is a who's-who of left-wing individuals and organizations with senior directors, advisors and attorneys from some far-left groups that include:

- Protect Democracy
- The Brennan Center for Justice
- The Southern Poverty Law Center

The Brennan Center for Justice is listed as one of the funders of this new committee and it also helps fund Protect Organization. These progressive anti-freedom organizations stand together in their efforts to circumvent the U.S. Constitution and Bill of Rights and consistently go after conservative patriots.



These anti-America organizations along and committee members have been exposed over the years for their roles in writing election legislation that has opened the floodgates for fraudulent voting including mail-in balloting and drop boxes. These leftist organizations have also provided legal representation for those who want to intimidate American citizens who question the election process.

As chairman of "The Committee for Safe and Secure Elections," Neal Kelley has an obvious

conflict of interest with his Orange County Registrar of Voters consulting position.

Conservative Patriots of Orange County calls on the Orange County Board of Supervisors to immediately rescind Kelley's consulting contract.




American Thinker

"Let's make them Middle Eastern. Tell wardrobe the girls wear hijabs, and the boys wear yarmulkes."


"The secret sauce! Is anyone focusing on what makes these burgers taste so good?"


