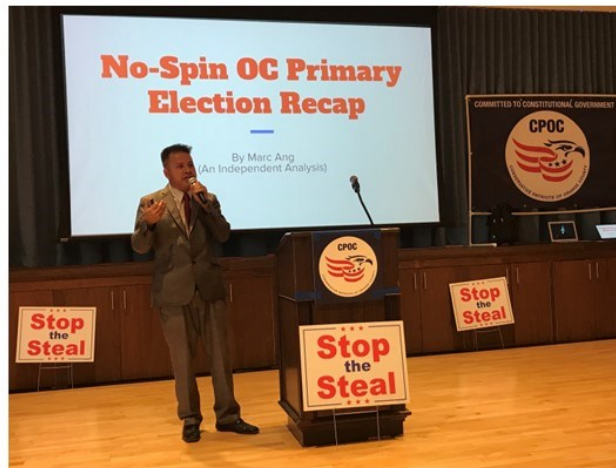

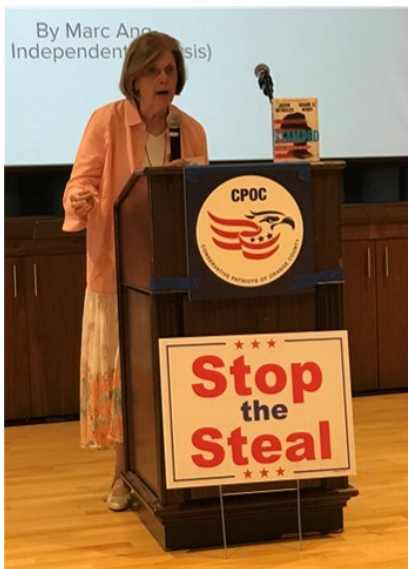

## CPOC Ramps Up for General Election Cycle, Holds Firm to Solid Principles

CPOC's core principles have landed on fertile ground and we are firmly planted to bear fruit. Our message, energy and commitment is resonating with an electorate that is hungry for action. People are sick of useless meetings, empty words and top-down directives. Our goal was to hit 200 members within 6-months of operation. We exceeded that.

CPOC is an autonomous non-partisan, 527 political not-for-profit with membership open to a broad spectrum of political affiliations. We support limited government, local control, sound fiscal management, the free market and holding elected officials accountable.

CPOC adheres to the values and principles of our nation's founding as contained in the Constitution of the United States of America.

We will not blindly support "establishment-blessed" candidates. There may be times when they are aligned with us. Then we can work together for mutual victory. However, we will not and cannot unite behind globalists or swamp-dwellers. We are looking for well-reasoned and consistent warriors for America. As Constitutional Conservatives, the only reasonable course of action is to put America First.

More evidence of the **civil war** raging within the Republican Party emerged over the summer. (No, I'm not talking about Liz Cheney.) As CPOC and similar groups ramp up to preserve our Constitutional Republic, the state and county GOP ramp up their attacks on America First candidates and policy pursuits. Be sure to read articles on pages 7 - 9. GOP meddling has caused discord amongst the base at the far north and far south ends of Orange County.

There truly is nothing new under the sun. The GOP was endorsing its chosen and "blessed" candidates even before close of filing. Most disturbing was the interference by Orange County Superior Court Judge candidate Peggy Huang, who, by all reports, appears to have been in gross violation of California's Code of Judicial Ethics — notably Canon 5. # The First Income Tax

Granted there was no IRS in 1861, but President Abraham Lincoln imposed the first federal income tax by signing a Revenue Act on August 5, 1861. But wait a minute, he had a good reason for doing this. Strapped for cash with which to pursue the Civil War, Lincoln and Congress agreed to impose a 3 percent tax on annual income over \$800.

As early as March 1861, Lincoln was worried about the federal government's ability to wage war against the south. He sent letters (now in the Library of Congress) to cabinet members requesting their opinions as to whether the President of the United States had the constitutional authority to collect money such as this. Lincoln was concerned about maintaining federal authority over levying a tax on citizens as well as collecting revenue from ports along the southeastern seaboard. He wanted to make sure it would not fall under the control of Confederacy.

The Revenue Act's language was very broadly written to define income as gain "derived from any kind of property, or from any professional trade, employment, or vocation carried on in the United States or elsewhere or from any source whatever."

Ten years later in 1871, Congress repealed Lincoln's tax law. For 28 years the government constituted tariffs which were challenged. The Supreme Court became involved but it was President Taft set into the motion the 16<sup>th</sup> Amendment, his last presidential action before leaving office in 1909. When the 16<sup>th</sup> Amendment was passed it set in place the federal income-tax system we use today.

So now you know who to really blame when April 15<sup>th</sup> rolls around each year.

# Starbucks Says No to Mail-In Ballots

# OCGOP - Disappointment Wherever You Look

It is disappointing that the OCGOP made endorsements before the nomination period even closed.

What an irony that the 2020 elections were rigged by the Democrats, and now we learn that the endorsement process for the 2022 candidates have been rigged by the OCGOP.

Is Mission Viejo an unlawful government?

On July 25, 2022, The OCGOP endorsed two Mission Viejo Council Members, Ed Sachs and Wendy Bucknum, who have been named in a lawsuit for extending their terms in office.

Mission Viejo Council Members Wendy Bucknum, Ed Sachs, and Greg Rath have stayed in office beyond their two-year elected terms.

On August 30, 2022, Judge Schwarm in the case of *The People of the State of California vs. Sachs et al*, Case #30-2022-01262431-CU-JR-CJC, will make a ruling if Council Members Bucknum, Sachs and Rath will be removed from office.

The OCGOP also endorsed an additional two Mission Viejo Council Members, Trish Kelley and Brian Goodell, who quietly intended to stay in office beyond their expiring terms.

On September 14, 2021 councilmember Trish Kelley made the following comment: "To be clear, there will be three seats up for election, not five, three districts."

That statement was made months before there was even a district map. These same council members gamed the system to retain to their seats.

But on June 28, 2022, at the conclusion of a second lawsuit, Case # 30-2022-01253878-CU-WM-CJC, challenging the Mission Viejo council members for intending to stay in office beyond their term, Judge Schwarm ordered that all five districts are to go out for a vote, not three, as determined by the Council in September.



Did the OCGOP Endorsements Committee properly vet these candidates? Did they research their voting records? Did the candidates mislead the committee members?

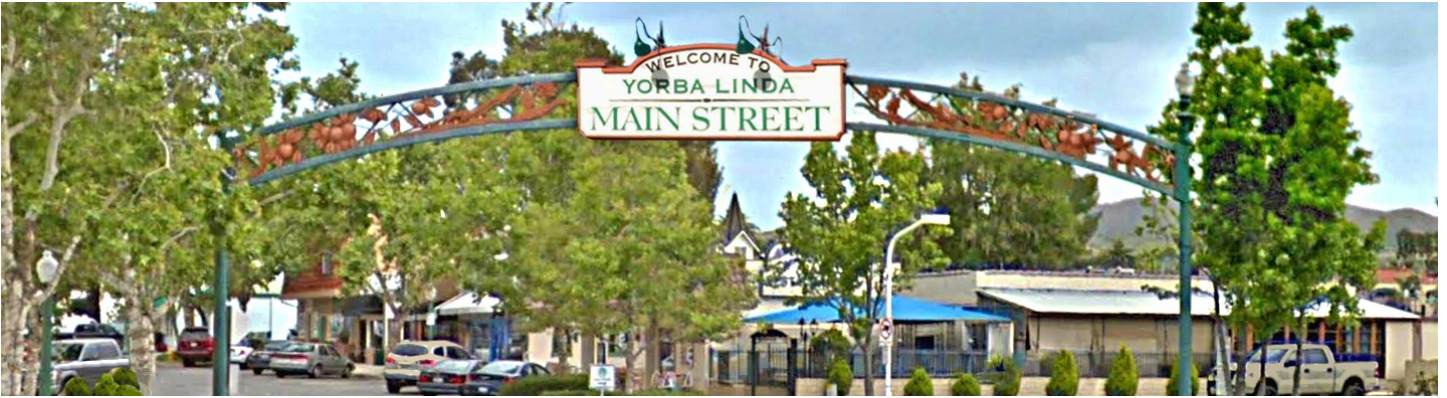
If the OCGOP is going to simply endorse city council incumbents, just because they are incumbents, then they better do their job and research the candidates voting record and campaign finance statements. If they had done their research, then it would have been discovered that these Mission Viejo incumbents have been endorsed by and accepted union money. Were the incumbents asked their positions on taxes? They wanted to increase the hotel tax. These council members, also this summer, wanted to consider cannabis dispensaries. But it being an election year, both items were dropped, not on principle but on politics. After the council voted to purchase the Casta del Sol Golf Course, these council members then voted to eliminate street sweeping as a city service and added the cost to our trash bills.

The OCGOP touts its conservative values, yet the Mission Viejo City Council voted to buy more private property, the vacant Stein Mart building for public use. To fund the \$12 million purchase, they voted to incur \$46 million bonded indebtedness that will be a \$60 million burden to the general fund.

The OCGOP endorsement has extraordinary power to elect Republicans into office. But abuse or cronyism dilutes our Republican party with RINOS, who are currently Mission Viejo Council Members.

Truths and values of our party are important. But if no one is doing the hard work on vetting these candidates then not only will the voters lose faith, but the Party will be fundamentally weak, by supporting sham candidates.

If the OCGOP is not going to do its job and vet candidates, and welcome fresh faces into the Party, then it needs to stay out of the council races and let the voters decide.



# How the OC GOP Helped Peggy Huang and Hurt Yorba Linda, a Town Huang Claimed to Love

It appears that the OC GOP has done it again! The OC GOP put "their people" ahead of what is best for the region they hope to represent. All the while helping one of their own hurt her own career!

It all happened at the July Central Committee Endorsement meeting. The City of Yorba Linda has two candidates running for city council and seeking the OC GOP endorsement:

- Jess Battaglia, beloved hometown candidate
- Janice Lim, a career politician

It's wonderful having multiple people wanting to represent your city. It's not wonderful having the OC GOP go against the city's wishes. For example, it would have been great if OC GOP had not asked the candidate who didn't receive their endorsement to back out of the race. Both candidates went into the meeting with a neutral vote from the endorsement committee, but Peggy Huang believed she had the right to pick her successor. Huang believed this was even more important than her run for judgeship. Why do I say this you might ask? In Huang's desire to pick her successor she violated rules set forth as she runs for judge.

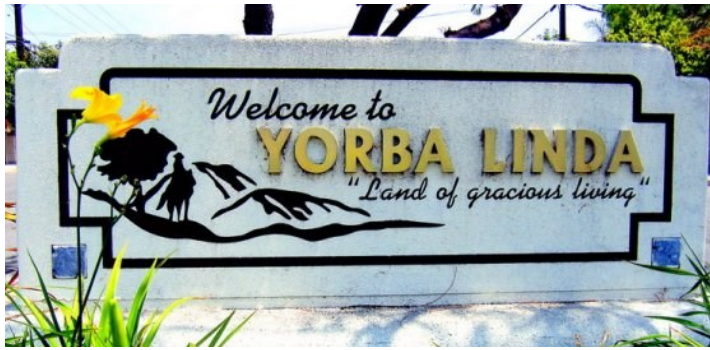
There were lots of moving parts to all of this.

In an unprecedented move, OC GOP asked Yorba Linda's current city council members to share who **they** preferred to have seated with them on the 2023 council. The majority leaned for Battaglia (the Yorba Linda hometown boy), but two members (Peggy Huang being one of the two) wanted her pick. In the process many rules and hearts were broken.

Huang made it her mission to have OC GOP floor voting the way she wanted it to go. She called Fred Whitaker, chairman of the OC GOP, and told him that she was endorsing a career politician. In addition, favors were called in from people like U.S. Rep. Young Kim and State Assemblyman Philip Chen. Why are these elected officials so interested in the Yorba Linda City Council? So interested that they willingly handed over their seats that night to Huang's friends. As Huang worked the room before the meeting even started, people were put in place to vote on behalf of who Huang wanted.

The night started out with Chairman Dr. Jeff Barke bringing to light that Yorba Linda's City Council responded to their request and has endorsed Battaglia. When Whitaker takes back the podium, he states he would like it to be known that Peggy Huang called him directly and has endorsed Lim for city council along with other city council member Tara Campbell. Huang was so determined to get her way made a HUGE mistake in her run for judge. *continued*





While being at the OC GOP endorsement meeting was bad enough, Huang publicly endorsing any political candidate is a huge issue while running for judge.

Then each candidate had their three people speak on their behalf. Tara Campbell, stated she has worked with Lim for years, and Peggy is the one who is leaving the seat and she has endorsed her to be her successor!

Since when does an elected official get to pick their successor? This was bewildering to me.

Judges are supposed to stay neutral. I was almost happy to know the same goes for judicial candidates. Per Judicial CANON 5 rules. CANON 5 clearly states:

"They shall, however, avoid political activity that may create the appearance of political bias or impropriety." Yet she just endorsed a candidate as a republican running for office. CANON 5 also states "judicial officers may only endorse candidates for judicial office; they may not endorse non-judicial candidates."

The last time I checked, career politicians are not judicial candidates. So, we are two for two, but it gets better. The JUDICIAL CANON 5 goes on to say:

"You may offer private advice on campaign matters, including strategy, fund-raising, and by identifying persons or entities who might be helpful to the candidate. However, you may not publicly assist the candidate in any way, such as by introducing the candidate to potential supporters or contributors, or by allowing your name to be used."

Well, that clearly didn't happen as Huang's name

was specifically used twice to endorse the candidate. CANON 5 goes on:

"Care must be taken to ensure that the event is promoted, advertised and run in a manner that does not appear as if you are endorsing any of the non-judicial candidates."

And there it is! Clearly, CANON 5 had been broken multiple times throughout the meeting. So, Peggy Huang, who claims to love her town of Yorba Linda, has now put her wishes before the town along with diminishing her chance at becoming an elected judge.

When you analyze what took place, you must wonder what would make a person who claimed to want nothing but the best for the city she has been serving do this? What would be so important that they might give up being elected to a judgeship? Is it money, power, blackmail? We may never know, but what we do know is Huang broke the Judicial Canon 5 rules.

Should we just forget it since we are repeatedly told it's better than a Democrat holding the seat? No, it's not. At least with Democrats you know where they stand on issues. You can disagree with everything, but you know their progressive values border on Marxism. When dealing with someone who says all the right things to your face, but then turns around and does what is best for themselves, the situation never improves. Public servants like Peggy Huang are supposed to serve the community which they represent. When they start serving themselves, conservatives should hold them accountable. We need to say "no more" to self-serving politicians!

# Greetings from Arizona

It was such a pleasure to attend the June 2022 Conservative Patriots of Orange (CPOC) meeting and look out over the Elks Lodge ballroom to see a 100+ energized Conservatives. You could feel the excitement of every member. The agenda was packed with informative speakers and pertinent action opportunities.

I am very proud of the handful of women from Orange Republican Women Federated (OC RWF) who ventured out on their own last fall, overcame many obstacles, and created a new organization based on a broad inclusive narrative of Conservatism. I applaud the commitment of President Deborah Pauly who graciously picked up the gavel and turned CPOC into the organization we envisioned. Deborah is an amazing leader who has always put Conservatism, Faith, Country, and Freedoms at the top of her "Things to Do List."

Just what are the roots of CPOC?

As Orange Republican Women Federated continued to struggle trying to develop an active membership, the board of directors and I knew we had to take a different approach. Our vision of an organization that embraced many different political Conservatives started to take form. We had our work cut out for us as our mission meant that we would sever our relationship with the California Federation of Republican Women (CFRW) and jeopardize our partnership with the Orange County Republican Party (OC GOP). This ended up being a formidable task. But amid allegations of improprieties, threats of lawsuits, banned membership in any Federated club, name calling, and behavior not in the likeness of a Republican lady, we made it happen.

Orange RWF was dissolved and CPOC emerged with an energized board of directors ready to take on anything. We were no longer the "ladies who lunch!" Our quiver is full and CPOC is ready to take on the Democrats and the GOP Establishment. I am proud to be the founding president of such a dynamic organization.

In May of 2021, my husband and I made an unplanned move to Arizona. Moving to a new state meant that I needed to start all over in terms of getting to know the political landscape. Arizona does not have an open primary so fortunately, Republicans can only vote for Republicans. Local FOX news anchor Kari Lake won the Republican nomination for governor with 47% of the vote. Kari was endorsed by President Trump. He made several trips to Arizona in support of her and his chosen candidates.

Facing off against Democrat incumbent Senator Mark Kelly will be Blake Masters, another Trump endorsement who won 40% of the vote in a crowded field. Republicans Mark Finchem (secretary of state) and Abraham Hamadeh (attorney general) also won their nominations and were Trump endorsed.



Overall, President Trump's endorsements carried the Republicans across the Arizona finish line. Now that the primary has been settled, you would expect to see the candidates hitting the campaign trail, but unfortunately, it's only the Democrats going door-to-door and buying TV time.

I don't think the Republicans have the money since the primary was so brutal.

Vote manipulation in the 2022 primary determined the outcome. The reality is 281,077 people voted for the 2022 primary in Orange County. This is based upon CPRA requests for Vote by Mail ballots and website data on June 7, 2022 at 10 P.M. Orange County reported 636,497. Interesting the warehouse had 1,286,846 total votes - based upon CPRA request.

**In summary, OC received 281,077 votes but the criminals stealing our elections had 1,005,769 ballots in reserve to help the chosen candidates win.**

The election stealers only needed 355,420 of the 1,005,759 to bring the victory to the chosen candidates. Three prior Grand Jury Reports pertaining to election irregularities in Orange County, were lauded by the GOP party, BOS, DA and Sheriff who stated that Orange County is the Gold Standard of Elections for the Country. The criminals now feel emboldened, and this election is much worse than the last mid-term election in 2018. In 2018, when OC started to count warehouse ballots the unused credit line was 300,000. This primary election was double that!

**People are no longer elected in Orange County they are chosen.**

At this point I believe the bond claims are our best approach to cleaning up our Third World Elections.

Our path forward, will be to refile the bond letter directly with the surety bond company Fidelity and Guarantee. We learned that giving the bond claim letters to the County Clerk was counterproductive, as the County Clerk does not have the integrity to follow the law and to forward our claims to the insurance company. He will have his turn to correctly follow the process, on our next bond claim. A team member did file a claim against a city in Orange County and at the same time, sent it to the bond company. That claim is presently being litigated via a court battle between the insurance company and the city. Our team member has a claim number and assuming the insurance company wins she will have the city issue fixed and a larger bank account as a result. We are refiling using the same process.

In a way it is a blessing from the LORD that we are refiling the Bond claim. We have doubled the evidence of fraud that we had a few months ago. We acquire new data every week. It is the gift that just keeps giving. Amazing how deep the well of election fraud goes. However, since we have been doing this for less than two years and the criminals have been stealing elections since the 1960's, we should not be surprised that they have a head start on us. Some of the new evidence we have are:

Scanners are Canon products and allow imaged ballots to be deleted, replaced, or modified. They also are scanned to a pdf which can also be fully modified to suit the desire of the Criminals stealing our elections.

The poll pads are online, and changes can be made remotely to our voter rolls including allowing people who



have given a bad address like a parking lot the right to vote. The poll pads are giving data to the ballot traffickers on who has not voted. We have CPRA requests from the SOS, ROV and a whistleblower to prove this legal violation of CA Election law – internet access.

The Halderman Declaration. Dr. Halderman is one of the leading experts for voting machines recognized by both parties. Neal Kelley had him at UCI at a summit in 2019 to push the Russia Russia Russia narrative from a voting machine standpoint. 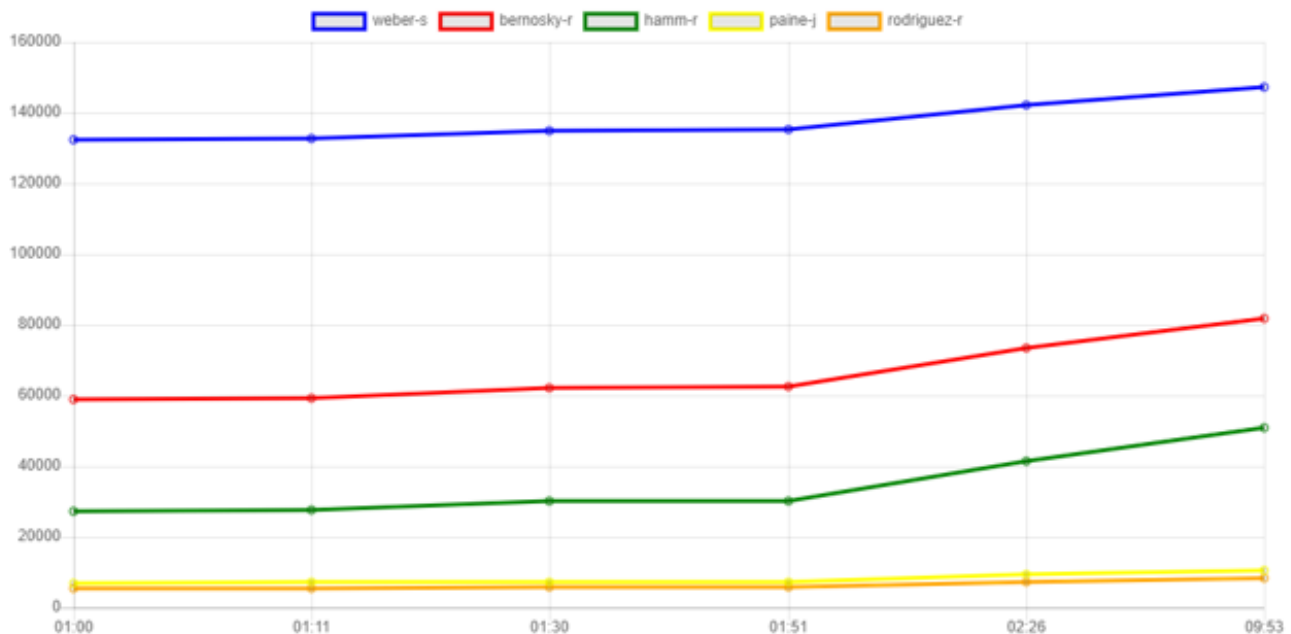

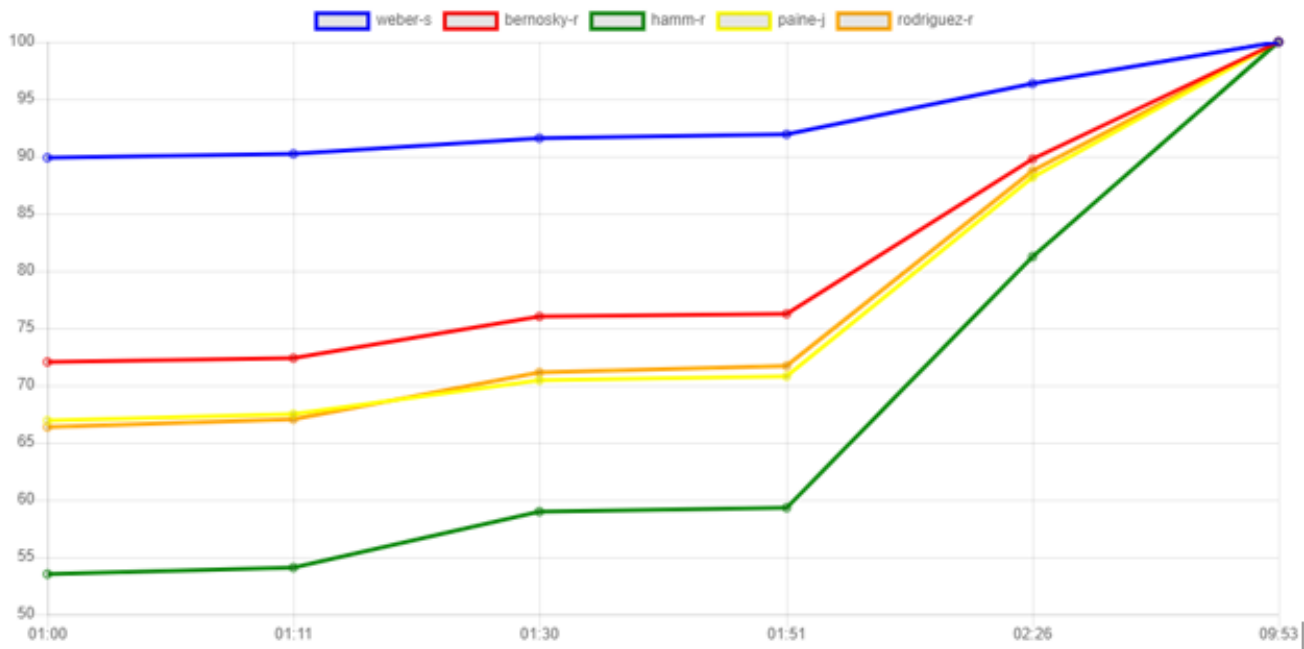

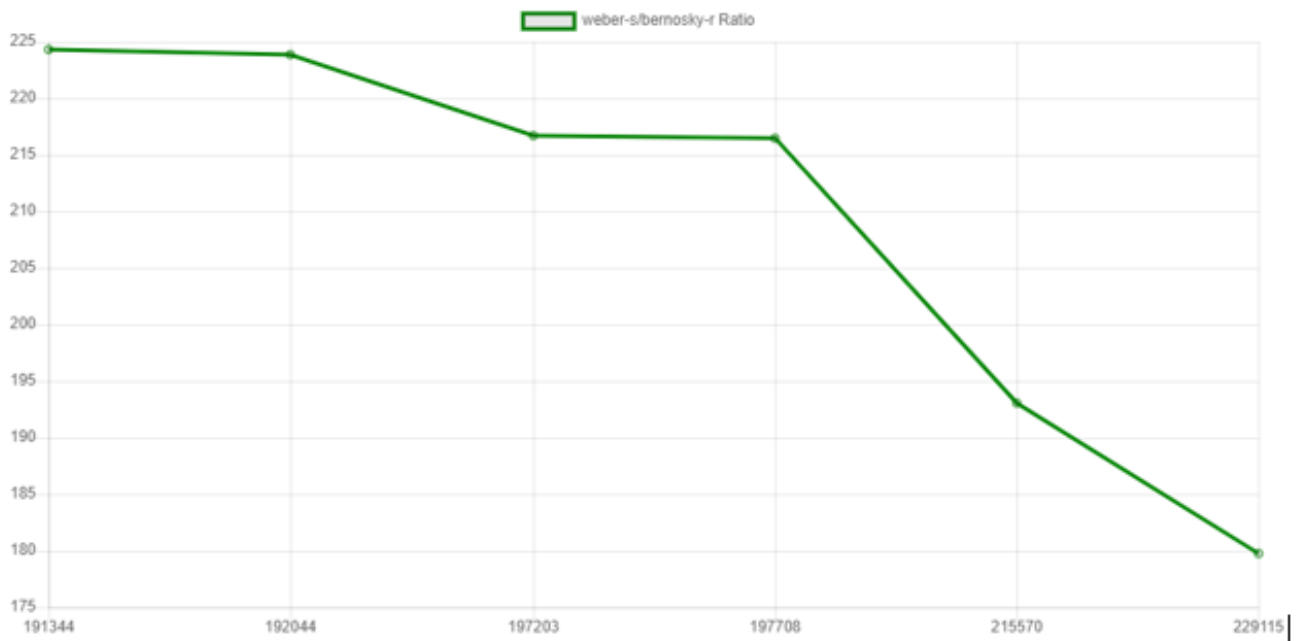
