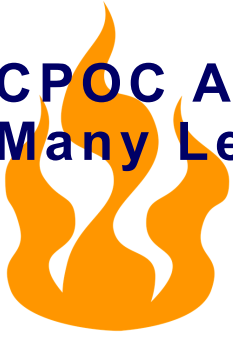

# PAULY'S PERSPECTIVE

A Message from Our President Deborah Pauly, J.D.



## CPOC Activists Are on FIRE! Many Leaders Emerge, Connect & Develop



CPOC's mission is to connect and serve the liberty-minded, patriot community in Orange County. We network with many other activist organizations and work with them for the cause of affecting good government. What is good government? To our way of thinking, it is one that is responsive to the legal citizens, puts America First and does not offend the freedoms given to the people nor the constraints placed upon government's authority to act as delineated in the U.S. Constitution.

Good government is limited in power and the scope of its authority. It is locally controlled and not dictated to us from on high. It exercises sound fiscal management and honors the free market economy without undue interference.

That should be a pretty simple matter, but instead, it's a battle.

It's a never-ending battle because ***power tends to corrupt and absolute power corrupts absolutely***. That was an observation by renowned 19th century philosopher Lord John Emerich Edward Dalberg-Acton that **a person's sense of morality lessens as his or her power increases**.

It doesn't help when those placed in positions of power arrive there with significant pre-existing deficiencies in morality and ethics. Nowhere is that truth more fully demonstrated for us than before the Orange County Board of Supervisors (OC BoS).

One of CPOC's five core tenets is that we **hold elected officials accountable**. At the OC BoS, this is a never-ending battle and one that is rarely satisfying. Yet, we are called to persevere, to maintain that purpose in spite of difficulty, obstacles or discouragement. A team of CPOC members and associated activists have steadfastly monitored OC BoS agendas and attended twice monthly meetings to hold them and county staff accountable for myriad offenses against the best interests of the people.

Month after month, citizens have been calling on the OC BoS to look into concerns about the integrity of elections in our county. The Board finally placed on the agenda an item to "**receive a status update** from the Registrar of Voters on the next election cycle and County **compliance with election laws**." It was really just an orchestrated dog and pony show that included a "there isn't anything to see here" slide presentation.

Over 70 Orange County patriots showed up for that April 25 meeting and 35 submitted speaker's cards. The board reduced public comment speaker's times from 3 minutes to only 1 1/2 minutes per person. The citizens were not worthy of 105 minutes (35 speakers X 3 minutes). Yet, we sat and listened to them blivate for over 110 minutes on this agenda item.

The board completely failed to address multiple requests that the ROV provide notice and hold a new public hearing under the Voter's Choice Act and submit a new plan to the state amending how we will hold elections in Orange County. That must happen 120 days prior to the next election. The next election is the presidential primary slated for March 5, 2024. Instead, they intend to press forward and not hold a hearing until 2025. Of course, that will be too late to salvage a broken system that's designed to permit multiple points of entry for fraudulent votes.

Here's the real kicker: Those 70-plus patriots — legal citizens — waited patiently as the OC BoS unanimously voted to establish an Office of Immigrant and Refugee Affairs, to serve the interests of non-citizens, with a financial impact "to be determined," according to the staff report. There were 53 speakers for that item. These speakers were given the full 3-minutes per person. You can read all about Item #42 by clicking [here](#).

You may view the video [here](#). Just scroll down the agenda to your left and click on Item 42. The video automatically skips to that point in the meeting.

Item #42 went into the lunch break and lasted about an hour and a half. Those who wanted to address election integrity were required to leave, find lunch and reenter the palatial new Hall of Administration digs. We are subjected to invasive searches of ourselves and our belongings. Sheriffs deputies were going through nearly every item in ladies' purses, including opening wallets, lipstick cases, glass cases and every zipper compartment. Every time you leave to go to one of three the gender neutral bathrooms down the hall, you have to re-enter through security. This is what must be endured just so we can redress our grievances to elected officials.

Many citizen leaders have emerged and one of the greatest among them is CPOC member Katie Harkins, who has coordinated volunteers, monitored board agendas, provided talking points to inexperienced board attendees and faithfully spoken truth to power during public comments at nearly every meeting. As Tucker Carlson said upon being fired from FOX news, when someone speaks the truth, they become powerful. This is a powerful woman — a powerful woman with a servant's heart.

We are blessed to have many powerful truth-speakers emerging as leaders from within our membership. We support and lift up each other in that endeavor.

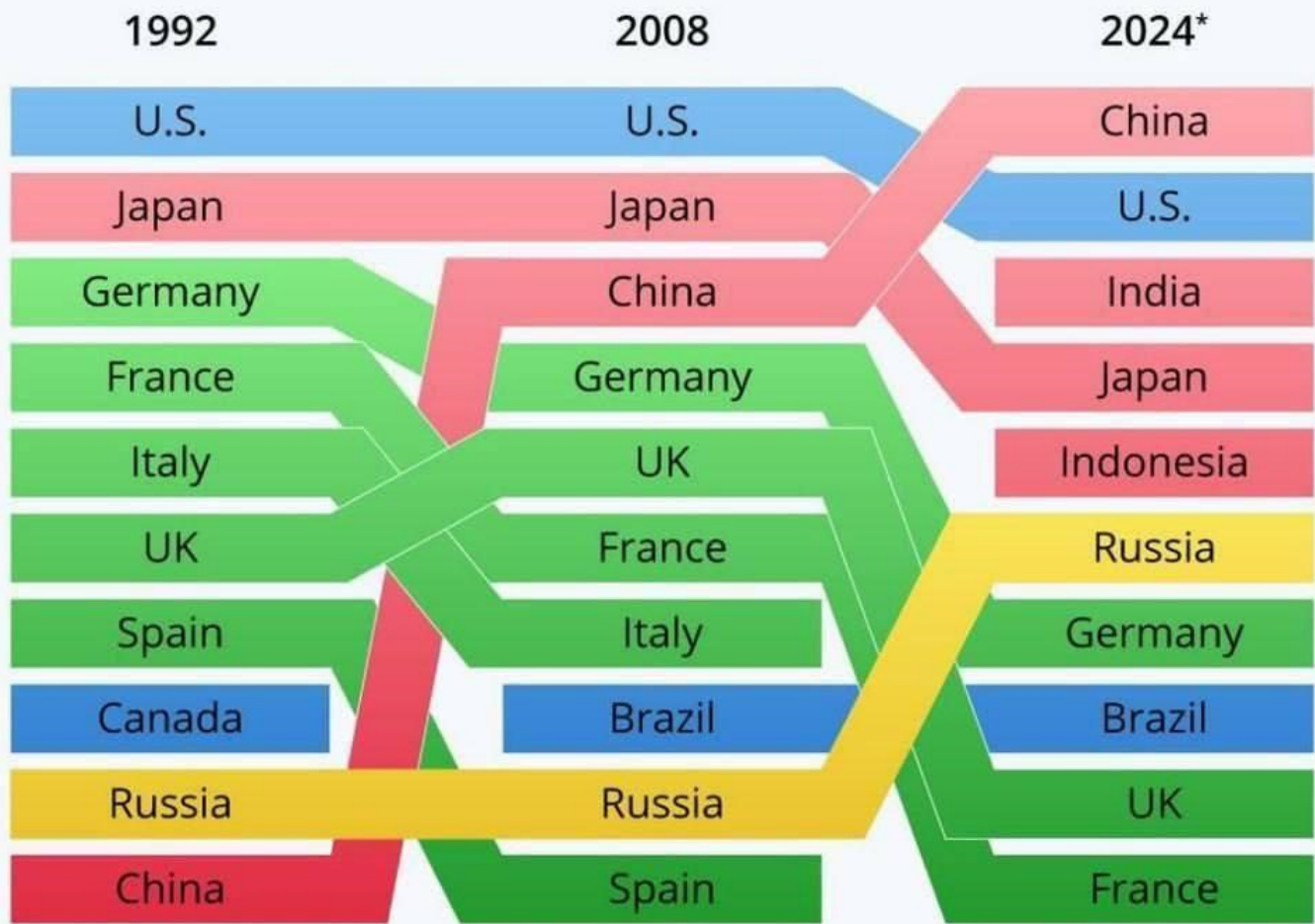

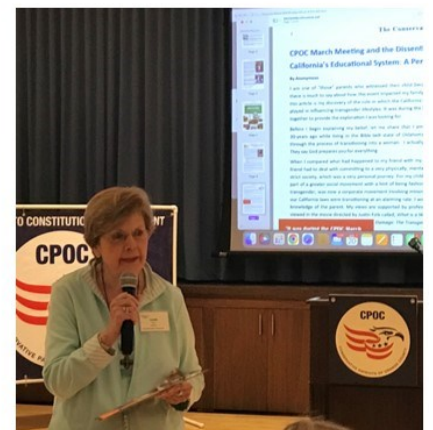

We also saw a video from the 2022 City of Orange Parade.

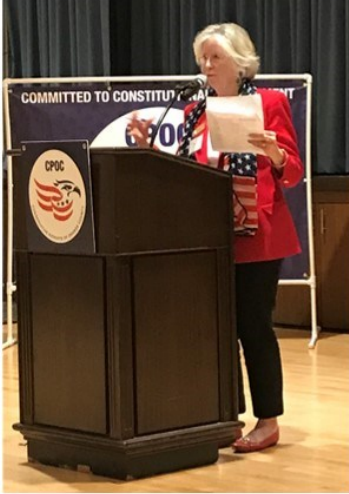
Before breaking for a delicious Americana dinner, Deborah detailed the calendar for nominating and electing members to the OCGOP central committee.

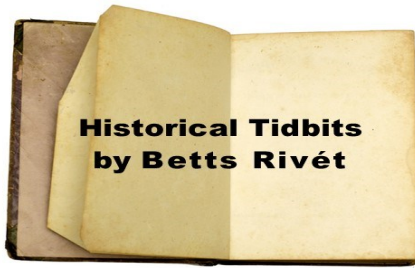

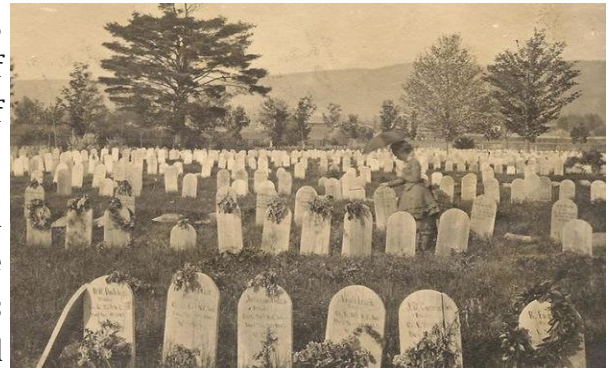


# Decorations Day & Memorial Day

Decoration Day originated in 1865 during the American Civil War when citizens placed flowers on the graves honoring those who had died in both the Union and Confederate armed forces. Then in 1868 John A. Logan, a member of an organization of Union veterans, promoted a national holiday on May 30 "for the purpose of strewing with flowers or otherwise decorating graves of comrades who died in defense of their country."

The name Memorial Day which became more common than Decoration Day after World War II but was not declared the official name by federal law until 1967. Then in 1968 Congress passed the *Uniform Monday Holiday Act* which moved Memorial Day from its traditional May 30 date to the last Monday in May. That law did not take effect at the federal level until 1971. After some initial confusion and unwillingness to comply, all states finally adopted Congress's change of date a year later.



Memorial Day is observed with laying a wreath at the Tomb of the Unknown Soldier in Arlington National Cemetery and by flags and flowers being placed on the graves of veterans in local cemeteries. There are religious services, parades and speeches devoted to honoring veterans who lost their lives in battle.

In 2000, Congress passed the National Moment of Remembrance Act asking people to stop at 3 p.m. to remember the veterans who died for our country.

On Memorial Day, the US flag is raised briskly to the top of the staff and then solemnly lowered to the half-staff position where it remains only until noon. It is then raised to full-staff for the rest of the day.

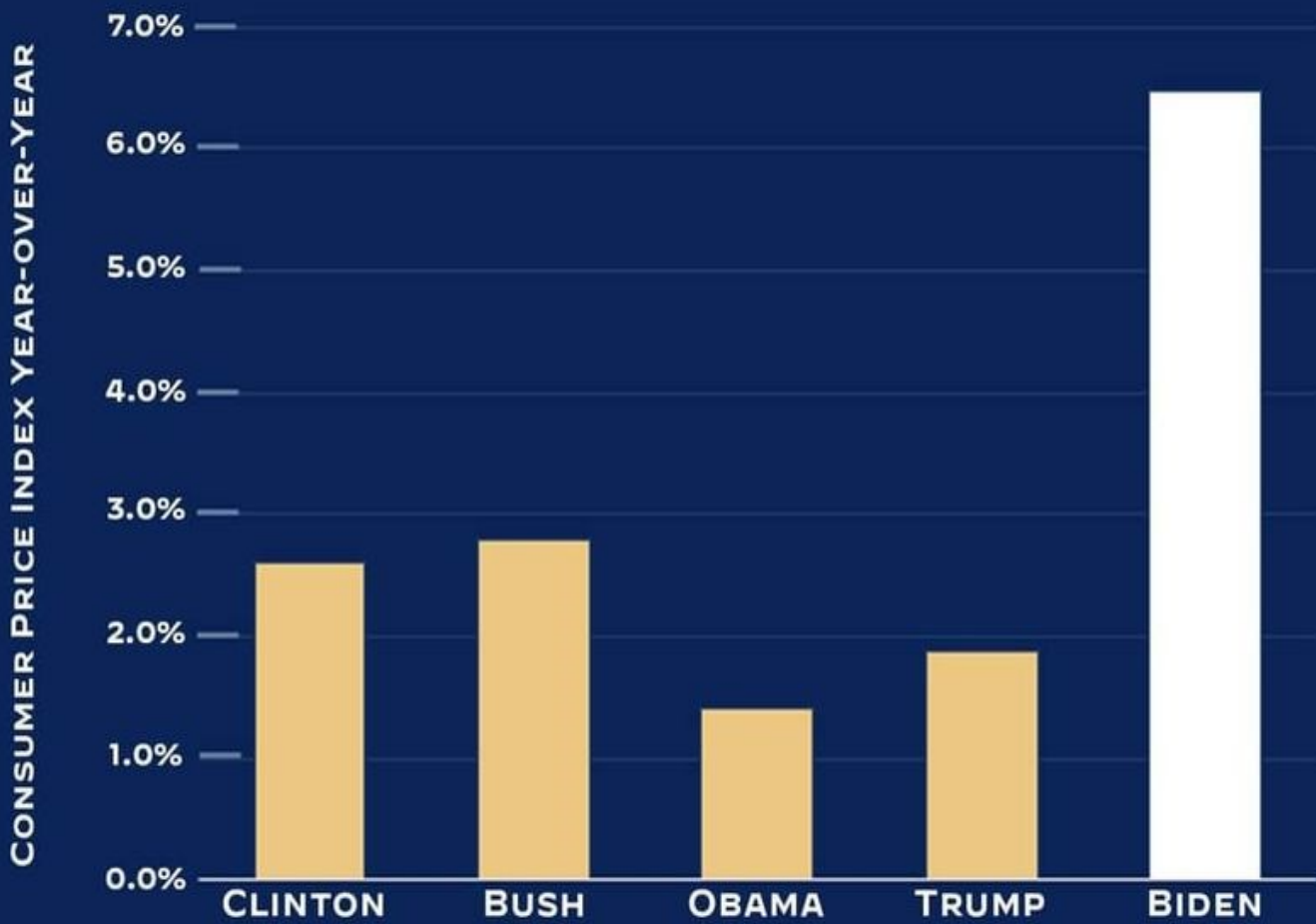

## Anatomy of an Election Type: Precinct versus Voter's Choice Act

Utilizing a combination of Registrar of Voters Public Records Request and data located on the ocvote.com website, the following is a comparison of election related data. The general midterm elections of 2018 and 2022 were selected to avoid COVID-19 influence and the first VCA election in 2020.

### Arguments to Bring Back Precinct Elections

- Purpose of VCA was to increase voter turnout.
  - 2018 Precinct voter turn-out was 16% higher than 2022 VCA election
- Integrity of elections has been compromised with VCA
  - 60% of the Dropboxes are unmonitored.
  - Use of data transmission over wireless broadband network
- Increase in cost of elections.
  - Overall costs increased by 25%; individual city costs increased by 40-50%
- Reduction in number of in-person voting options (potential reason for reduction in voter turnout)
  - 984 in-person voting options with Precinct voting, 181 with VCA (81% reduction)
- Delay in receiving results with VCA

*I researched Hart InterCivic Verity Vote and they have modules and equipment that don't need broadband.*

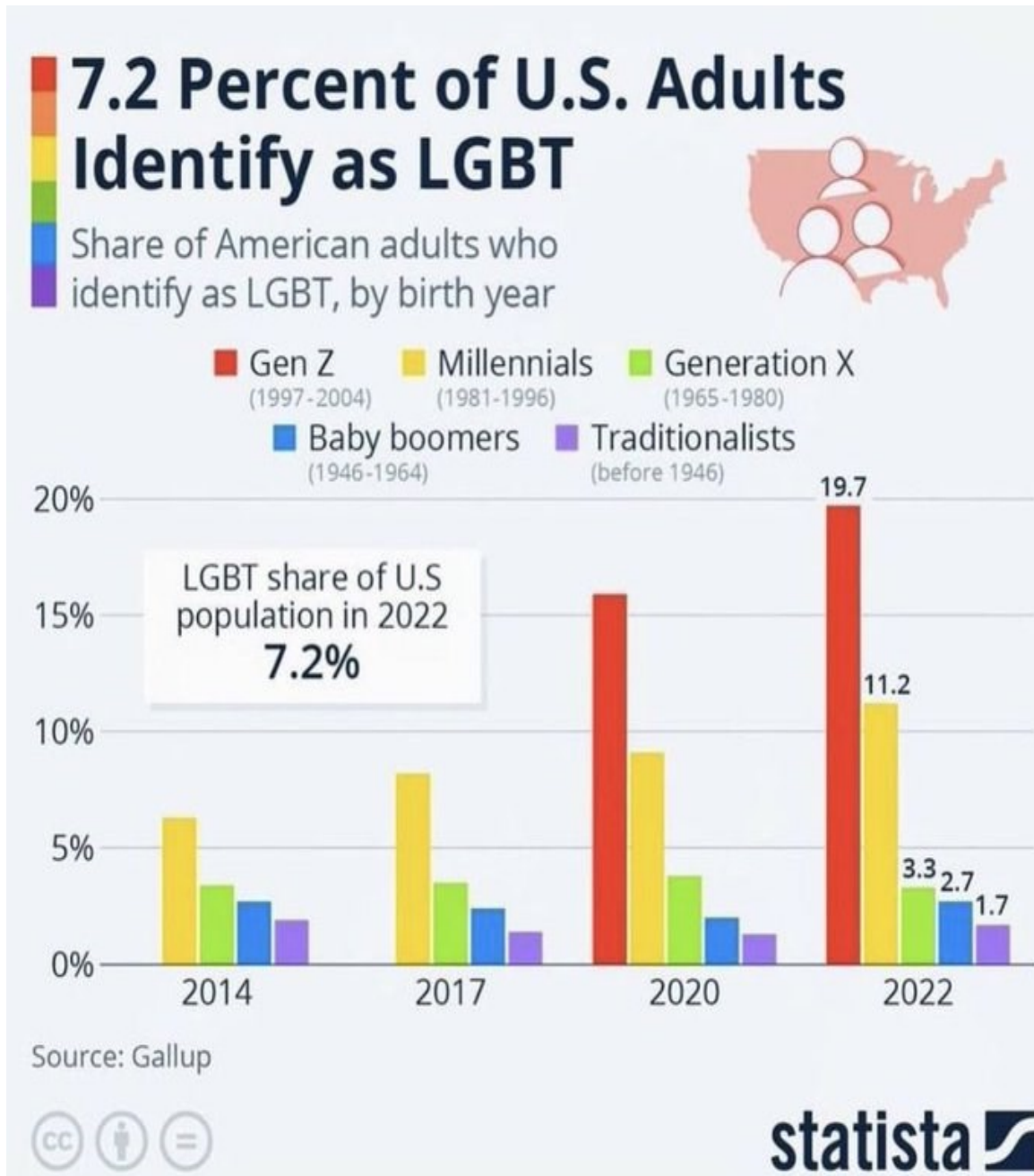
We can't get enough volunteers to staff the precincts.

*I saw this argument as one reason the ROV wanted to use vote centers and dropboxes. They have always been able to obtain volunteers in past years.*

We don't have enough time before the 2024 primary election.

*SB 450 and current election code allows a ROV to amend the election administration plan 120 days before an election.*

## Congressional Districts

### California's 45th District

To date, no MAGA candidate has announced an intention to challenge Republican Establishment candidate Michelle Steel in California's 45th Congressional District. There's still time, but name recognition is important in a primary, especially when running against an incumbent who has already been endorsed by the lackluster Orange County GOP.

Over on the Democrat side, it's a different story. There are currently three progressives who have tossed their hammer and sickle into race. They are:

- Cheyenne Hunt: University of California—Irvine Law School alumna
- Kim Nguyen: Garden Grove City Council member
- Aditya Pai: Brea lawyer

There might be more candidates announcing, but for now the primary entertainment will come from progressives trying to out-progressive each other.

Steel represents a district that is 38% Democrat, 32% Republican and 25% No Party Preference. Obviously, she cannot win reelection unless she gets every Republican AND NPP vote (as many NPPers are fed-up Republicans). She needs to forcefully show her "America First Patriot" credentials. If Steel plays both sides of the street, she will find herself out on the street after the 2024 election.

### California's 47th District

In "Democrats to Focus on State in Their Bid to Retake House" (April 18; *Los Angeles Times*) Seema Mehta writes:

**Democrats consider California pivotal to the party's efforts to regain control of the U.S. House of Representatives in 2024, with**

**a super PAC tied to former House Speaker Nancy Pelosi pledging last week to spend \$35 million on competitive congressional races in the state.**

**That's roughly triple what the group spent in the 2022 midterm campaigns in the Golden State, when Democrats underperformed in heavily blue strongholds such as California while fending off an expected Republican red wave in congressional races across the nation.**

**"Democrats can't retake the House without winning seats back in California," said David Wasserman, a congressional forecaster for the nonpartisan Cook Political Report.**

CPOC-ers wonder why the OCGOP has endorsed loser Steve Baugh to run against Katie Porter in the 47<sup>th</sup> Congressional District. Perhaps the establishment OCGOP hopes that three times is a charm. (OCGOP has already endorsed Reps. Young Kim and Michelle Steel.) It appears the OCGOP wants to stop America First Patriots from running in the 47<sup>th</sup> Republican primary. How foolish! This would be an outstanding opportunity for an America First candidates to bring fresh ideas to the conversation and possibly win the election.

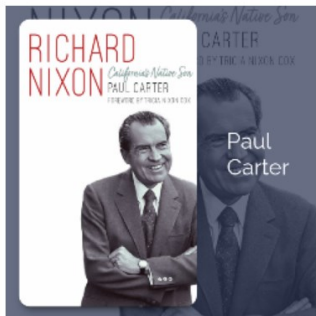
