A Message from Our President Deborah Pauly, Esq.



Do NOT participate in the Election Month fiasco; Vote on Election Day to help restore integrity

CPOC's Americanism Officer Betts Rivét reminds us that March is Women's History Month. You can read her Historical Tidbit in this edition of *The Conservative Chronicle*.

Personally, I detest identity politics, which is the tendency for people of a particular religion, ethnic group, social standing or economic background, to be susceptible to the suggestion that they form exclusive political alliances. Identity politics, as a mode of categorizing people, are closely connected to the forced acknowledgement that some social groups are oppressed, such as women, ethnic minorities, and people of divergent sexual orientations.

I'm still confounded by how women can fit into any minority category, since they comprise about half of the world's population. Ostensibly, it's because they do not share the same power, privilege and opportunities as men.

Identity politics is a method employed by the consulting class to divide people. It is often used in campaigns to manipulate people of the same "identity" into supporting one candidate over another:

- Vote for me, I'm The Only Woman!
- Vote for me, I'm The Only Korean!
- The Only Gay!
- The Only Black! etc. etc.

The mailers for this are targeted to voters of the same identity group. This is one of the reasons our country is so divided at present. It's part and parcel of the Diversity, Equity and Inclusion (DEI) paradigm. From Pauly's Perspective, it is particularly repugnant when Republicans employ identity politics during campaigns. We're supposed to be above that myopic thinking.

A healthier approach would be one that unites us by focusing on the content of our character — the inner person, how one thinks and the world view one overlays to that thinking. Identity politics has driven all manner of social movements that have lead to destruction and the unraveling of our once healthy (or at least healthier), functioning society. Identity politics is a wedge. It's not too late to salvage, if we can move away from it or refuse to be influenced by it.

Election Integrity

The March 5, 2024 Presidential Primary is upon us. It can't come too soon.

Some ill-advised, but well-meaning voters, cast their votes weeks ago, as soon as ballots hit their mailboxes because that is what the Republican establishment told them to do. Ballots were mailed by the Orange County Registrar of Voters (ROV) on February 5.

Others of us want to return to a time when the integrity of our elections was not so much in doubt. **We will Vote in Person, in a Polling Place, on Election Day, by Paper Ballot. We will not surrender our mail-in ballot, but require the polling place to print out a ballot for use. We will refuse to vote by Provisional Ballot.**

We have already had multiple reports of individuals receiving more than one ballot by mail or receiving ballots for relatives who are dead or have moved — sometimes out-of-state and years ago. We have reports of ballots not being received or of them being returned to the ROV, despite the fact that the voter has not moved.

If you experience FIRST-HAND or witness FIRST-HAND any irregularities, contact one of our Election Integrity Officers who will send you an affidavit to document what you have witnessed or experienced. 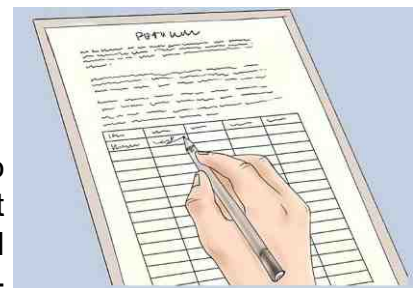

Protect Kids Initiative

After the break we will be drilling down into the next major task, which is qualifying The ***Protect Kids Initiative for the November 2024 General Election Ballot***. The state has misnamed this initiative as a statute to "Restrict Rights of Transgender Youth."

Well...not exactly.

What the statute would actually do is protect children by requiring schools to notify parents if there are mental health or gender confusion issues that need to be addressed; protect girls' sports by reserving them to biological females, and prevent sterilization or sexual mutilation of minors who are experiencing gender confusion while still too young to understand the long-term consequences of transitioning surgeries or medicines.

We are also in talks with staff for Assemblyman Bill Essayli, the leading proponent of this initiative. We are working out some scheduling conflicts. If all goes well, CPOC will be blessed to hear directly from this incredibly dynamic leader from Riverside County.

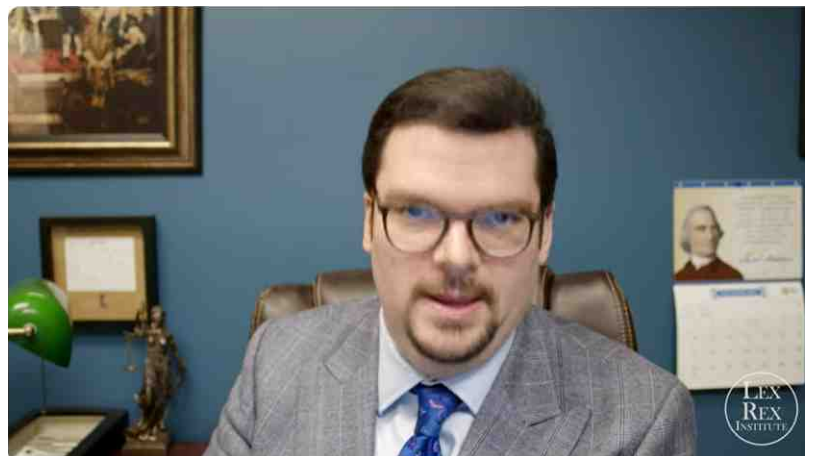

We had a great Public Outreach today at one of our best venues for the amount of foot traffic. Thanks go out to Jim for coming out and supporting today's outreach. By the end of the day, we had passed out a little over 700 brochures. And Jim had several good conversations with people regarding Islam. One included a lengthy conversation with a Muslim. He questioned Jim about what we were doing in a cordial way. Jim took the time to go over a few brochures with him and encouraged him to take them with him, but he didn't. Another conversation involved Jim talking with three college age men. They knew a little about Islam, but had plenty of questions. After about 20 minutes they walked away with several of our brochures. Another conversation Jim had was with a man very interested in what we were doing. By the end of the conversation he told Jim he would like to join in with us on future outreaches.

CPOC endorses Max Ukropina for California's 47th Congressional District

FOR IMMEDIATE RELEASE - Orange, California (January 19, 2024) — At its November general membership meeting, the Conservative Patriots of Orange County (CPOC) voted overwhelmingly to endorse **Max Ukropina** for United States Representative, 47th Congressional District.

The vote was taken by paper ballot after CPOC participated in lengthy, members-only, open floor discussions, vetting federal-level races touching Orange County. Candidates had presented themselves for consideration at previous sessions.

"Max Ukropina really impressed the room," said CPOC President Deborah Pauly, Esq. "He secured 83.6% of the vote, which is a very strong statement by the America First coalition. Max is a breath of fresh air and stands in stark contrast to the stale, retreads also running. Max is running on an 'America First' platform. His opponents seem to be running on a 'Money First' platform, which usually points to a globalist agenda. Voters are waking up to how damaging that has been to our country."

A 5-person team consisting of CPOC's Election Integrity Committee, its Chaplain and a member-at-large counted the ballots using the Shasta County Hand Count Voting Plan Method, where checks and double checks are implemented during the ballot counting. Any member could observe the vote tallying process.

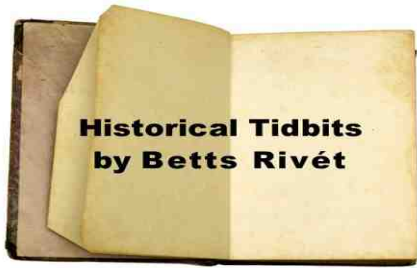

The Beginning of Women's History Month

More than 50 years ago, anything about women's history was virtually an unknown topic. However, in 1978 the first to initiate "Women's History Week" was a California Commission on the Status of Women in Sonoma County. The week of March 8th was chosen to focus on the topic of achievements of women. There was a student essay contest, a parade as well as many programs initiated by organizations and businesses depicting important women in history. Some were Florence Nightingale, Amelia Earhart, and Susan B. Anthony.

In 1979, many communities in other counties decided to get involved and agreed to support an effort to secure a "National Women's History Week." The first step toward success came in 1980 when President Carter issued the first Presidential Proclamation declaring to the nation that March 8th, 1980 as National Women's History Week. Four major issues were included in his proclamation:

- Women and men worked together to build our nation but women are unsung and their contributions unnoticed;
- He quoted Dr. Gerda Lerner, a noted historian, as saying "Women's history is women's right and is an indispensable heritage;"
- He urged schools and community organizations to focus observances on Women leaders who have struggled for equality; and,
- Understanding the true history of women in our country will call for ratification of the 27th Amendment of the Constitution to make sure that equality of rights can not be denied on the basis of sex.

Word spread rapidly across the nation. Soon governors, city councils, school boards and the U.S. Congress supported the concept of a women's history week. **BUT in 1987, Congress declared March as NATIONAL WOMEN'S HISTORY MONTH.** It took 17 years to reach this point. Now every year in March a special Presidential Proclamation is issued to honor the extraordinary achievements of American Women.

Let's make one thing clear: This OUSD recall, from the beginning, has been led and funded by the teacher's union. The California Teachers Association has contributed \$55,000 to the recall of two conservative trustees on the OUSD board of education.
